General Program Information

Accreditation

Things You Should Know Before You Apply

Upon acceptance into the Coastal Carolina Community College Associate Degree in Dental Hygiene Program, you will be required to:

- Have a physical exam and complete a Student Medical Form documenting a level of physical and emotional health consistent with the ability to practice dental hygiene in an entry-level clinical setting.
- Complete an eye exam with an optometrist/ophthalmologist.
- Document that you have had several required immunizations specified on the Student Medical Form.
- Be screened on admission and annually for tuberculosis.
- Obtain and maintain current certification in American Heart Association's Basic Life Support for Health Care Providers (often referred to as BLS or CPR).
- Travel at your own expense to clinical locations when necessary in order to complete clinical requirements of the program.
- Be a clinical patient for your classmates and be responsible for finding clinical patients to meet program requirements.
- At your own expense, have criminal background check and urine drug screening.

Students in the Dental Hygiene Program are required to abide by the Dental Department's Student Appearance Policy. This policy, which will be discussed further during the Information Session, provides details about what is expected in the classroom, pre-clinic, clinic, and lab settings. Students will be provided with greater information about general hygiene expectations as well as guidelines for jewelry, nail art, and body art. The Student Appearance Policy also contains requirements designed to protect students' health and safety, such as wearing personal protective equipment and appropriate footwear, securing long hair, preventing contamination, and displaying identification tags.

Before visiting military clinical sites, Dental Hygiene students will be required to have a criminal background check. These are needed to obtain access to the military clinics. The results are provided only to our affiliated clinical agencies. College administration and faculty are not, at any time, allowed to view the criminal background results. Results do not affect admission decisions; however, it is possible that the results may prevent the applicant from participating in the clinical rotations and from continuing in the program.

The Boards of Dentistry in all states also require fingerprints and a criminal background check prior to issuing a license to practice dental hygiene. A history of felony or misdemeanor convictions could result in denial of a license to practice dental hygiene.

General Attire Expectations of Dental Students

- Attire should be neat and clean.
- Shorts and jeans are acceptable as long as they are in good taste.
- Shorts, skirts, and dresses should be at least fingertip (appropriate) length.
- Shoulder straps should be at least 2" wide.
- Bare midriffs, strapless tops and dresses, spaghetti straps, one shoulder tops, low neck lines that reveal cleavage, and other types of provocative clothing are not to be worn.
- No undergarments should be visible.
- Long shirt/jacket must long enough to cover buttocks when wearing leggings/tights/very tight pants.
- Graphics/texts must be in good taste and not vulgar or offensive.
- No pajamas or slippers.
- All facial hair on men shall be well groomed and clean.

Materials Laboratory Attire

Same as General Attire, but also:

- Hair secured
- No "dangly" earrings (studs/small hoops only)
- No necklace
- No arm and hand jewelry (watch/wedding band-which must be removed depending on project/materials-keep in locker or home)
- No strings/straps on clothing
- Long pants
- Closed-toed shoes
- Lab apron
- Eye protection
- Dental shirts are welcome.

Pre-Clinical Attire (Non-patient Care)

- Hair neatly secured (off collar, hair restraints must be aseptic)
- No jewelry (nose, eyebrow, lip, tongue, ears, etc.) except watch/wedding band
- Clean, wrinkle-free scrubs
- Name tag
- White or black clinic shoes and socks (no holes, no laces, no mesh, heel strap/lip)
- Eye protection (side shields)
- Optional: Class jacket, solid long sleeve underscrub tee

Pre-Clinical/Clinical Attire (Patient Care)

- Hair neatly secured (off collar, hair restraints must be aseptic)
- Clean class surgical cap
- No jewelry (nose, eyebrow, lip, tongue, ears, etc.) except watch/wedding band
- Clean, wrinkle-free scrubs
- Name tag
- White or black clinic shoes and socks (no holes, no laces, no mesh, heel strap/lip)
- Clean, wrinkle-free class lab gown (fastened completely)
- Eye protection (side shields)
- Face shield (if aerosols generated)
- Gown and surgical cap must be placed in a labeled, zip-top bag at the end of the session, taken home and cleaned, and not hung in the clinic to be reused.
- Lab gowns are not worn outside of the Dental Clinic (into the hallway).
- Clinic shoes should not be worn out of the Health Occupational Science Building.
- No hangers are allowed in the Dental Clinic.
- Optional: solid long sleeve underscrub tee

Mask and gloves will be provided in clinic.

Dental Hygiene Program Requirements for Eligibility – Level 1

It is the applicant's responsibility to ensure that the following eligibility requirements (Level 1) are met before completing an Eligibility Application with any Academic Advisor/Counselor in Student Services (Level 2):

- 1. Complete the Residency Determination application. The application is available online at www.coastalcarolina.edu.
- 2. Submit an application to Coastal Carolina Community College. The application is available online at www.coastalcarolina.edu.
- 3. View or attend a mandatory Dental Information Session (see *Important Dates* for details).
- 4. Submit your official transcript(s) to the Admissions Office. Official transcripts include:
 - High school (or high school equivalency)
 - All colleges or schools attended after high school
 - CLEP (College Level Examination) scores
 - AP (Advanced Placement) scores
- 5. Meet math and chemistry pre-requisites as follows.

MATH: One of the following must be complete or in progress:

- Algebra II in high school with a grade of C or higher (must be 1 high school credit)
- DMA 040 Express/Lin Equa/Inequal **and** DMA 050 Graphs/Equations of Lines **or** MAT 070 Rational Express/Equation
- Complete MAT 003 Transition Math with a grade of P2
- College-level algebra course or higher (other than Statistics) with a minimum grade of C

AND

CHEMISTRY: One of the following must be complete or in progress:

- CHM 090 Chemistry Concepts at a North Carolina community college (Fall 2019 or later)
- A transferrable college-level Chemistry course (with a lab) from any college or university with a grade of C or higher within the past five years (Fall 2019 or later)
- Chemistry in high school with a grade of C or higher within the past five years (Fall 2019 or later) **AND** successfully earned a passing score on the Coastal Carolina Community College CHM 090 Chemistry Concepts Competency Quiz (provide a copy of the competency quiz results to the Academic Advisor/Counselor designated for the Dental programs)

If the applicant is currently enrolled in the math and/or chemistry prerequisites when completing the Eligibility Application, the Academic Advisor/Counselor designated for the Dental programs will verify that the required grade has been earned, and the Eligibility Application will be viewed as complete and submitted at that time.

- 6. Demonstrate college readiness in both English **and** mathematics by meeting <u>one</u>, or a combination, of the following to show required knowledge in each subject:
 - i. Graduated from any United States high school within the last 10 years with a GPA of 2.8 or higher, in accordance with Reinforced Instruction for Student Excellence (RISE) guidelines.
 - ii. Completed (with a minimum of the grade indicated) or enrolled in one of the following English courses:
 - DRE 098 (P)
 - BSP 4002 (P2)

- ENG 002 (P2)
- ENG 011 with ENG 111 (C)

- iii. Completed (with a minimum of the grade indicated) or enrolled in one of the following Math courses:
 - MAT 070 (C)

- MAT 003 (P2)
- DMA 010 DMA 050 (P)
- MAT 043 (P)

• BSP 4003 (P2)

- MAT 071 (P)
- iv. Completed (with a minimum of the grade indicated) or enrolled in one of the following:
 - ENG 111 (cannot be concurrently enrolled in ENG 011) or an equivalent college composition course (C)
 - MAT 143, MAT 161, MAT 171 (cannot be concurrently enrolled in MAT 043 or MAT 071), or an equivalent algebraic college math course (C)
- v. Completed a college approved placement test (e.g., RISE, NC DAP, Compass, ASSET, SAT, ACT, or Accuplacer/CPT) and meet the minimum college readiness scores, as provided in the College Readiness Placement Test Scoring Table. Test scores must be earned on or after August 1, 2021.

NOTE: For applicants using course completion to meet placement, both an English and mathematics option must be completed to meet the eligibility requirements, and applicants who are unsure whether or not they meet either the English or the mathematics standards should meet with an Academic Advisor/Counselor. Applicants taking a placement test at a location other than Coastal Carolina Community College must submit official test scores prior to meeting with an Academic Advisor/Counselor to complete an Eligibility Application.

Dental Hygiene Program Requirements for Eligibility – Level 2

- 7. Individuals who have met Level 1 eligibility requirements will need to meet with any Academic Advisor/Counselor in the Student Center on Coastal's main campus to complete an Eligibility Application. Please arrive no later than 30 minutes before closing.
 - Verification of points is completed *after* the application period has ended. Academic Advisors/Counselors will not be verifying points when meeting with the applicant to complete the Eligibility Application.
 - If an applicant currently resides at least 200 miles outside of Jacksonville, North Carolina, they must contact the Academic Advisor/Counselor designated for the Dental programs at (910) 938-6248 before January 26, 2024 to discuss other arrangements.
- 8. Submit documentation to earn additional points (see deadlines listed in *Important Dates*).
 - Any documentation for additional points that is received after the given deadline, regardless of the date postmarked, will not be considered.
- 9. Complete the Health Education Systems Incorporated (HESI) A² exam (no later than January 24, 2024) and earn at minimum the following scores:

If an applicant chooses to take the test at a site other than Coastal Carolina Community College, the official scores must be sent from HESI and received no later than January 26, 2024. See the *HESI Exam Details* page for additional information.

- 10. Ensure updated transcripts for courses completed in the Fall 2023 semester (if applicable) are on file at Coastal Carolina Community College by January 26, 2024.
 - Please be aware that if an applicant is completing the math or chemistry course required to apply during the Fall 2023 semester, and the transcript is not on file at Coastal by the deadline (regardless of the date postmarked), the applicant will be ineligible to be considered for the 2024 Dental Hygiene Program.

Content

• Students will be tested in the following areas: reading comprehension, grammar, vocabulary, and math.

Availability

• The HESI exam may take up to four hours. The exam is available Monday – Thursday (8:00 a.m. or 1:00 p.m.) or Fridays (8:00 a.m.), on Coastal's main campus. Available appointment times are viewable two weeks in advance. The testing schedule is subject to change.

Registration and Payment

- Applicants must register and pay online for the HESI exam ahead of time by setting up an Evolve/Elsevier
 account. The estimated cost of the exam is \$50, but it is subject to change. A study guide is available for
 purchase in the College Store.
- Payment must be completed at least 24 hours in advance of the testing appointment.
- Applicants will obtain the payment link from an Academic Advisor/Counselor after completing their Eligibility Application.

Schedule an Appointment

- Applicants should schedule an appointment with the Testing and Placement Center through the Admissions page of Coastal's website (click on the Placement Testing tile).
- If an applicant must cancel the appointment, they must notify the Testing and Placement Center at least 24 hours in advance. Failure to do so may result in an applicant being unable to make another appointment.
- Due to limited testing space, if an applicant misses or cancels two appointments, they will not be able to reschedule for two weeks after the last missed or cancelled appointment.

Scores

- Official scores will be available 48 hours after testing and may be viewed through an Evolve/Elsevier account.
- If an applicant decides to test a second time, they must pay the exam fee again (through a payment link obtained from an Academic Advisor/Counselor).
- Applicants may take the HESI twice in an eligibility period (September 1, 2023 August 31, 2024) at Coastal
 Carolina Community College. It is the applicant's responsibility to ensure they have earned the required HESI
 exam scores and that they have been received by the College by the January 26, 2024 deadline.
- HESI scores must be completed within three years prior to entering the program to be valid for the application process (in or after August 2021).

Off-Site Testing

- It is the applicant's responsibility to locate an alternate testing site. Coastal does not have a testing ID to provide to other sites.
- If a student tests at another site, they must request an official transcript to be sent directly to Coastal (through the HESI website) for an additional fee.

Remote/Virtual Testing

• A virtual testing option is available and subject to an additional fee. Please see an Academic Advisor/Counselor for more information.

Ranking and Selection of Dental Hygiene Qualified Applicants

Coastal Carolina Community College has a limited number of spaces available in the Dental Hygiene Program. Every year, the College receives applications from more qualified candidates than the program can accommodate. In order to be as fair as possible in making admission decisions among so many qualified applicants, Coastal has instituted a point system for ranking applicants.

Applicants will be awarded points for grades received in specific Dental Hygiene related courses based on the point system that best fits their profile. Courses taken for points must be completed by the end of the Fall 2023 semester.

Point Systems

There are two point systems:

- **Point System A** College classes
- **Point System B** High school classes

Points will be awarded for classes completed with a grade of C or higher. Grades of C- will not receive points. Additional points may be awarded for completing ACA 111 College Student Success or ACA 122 College Transfer Success with a grade of A.

Additional points may also be awarded for a student's Dental Assisting Program GPA, current Dental Assistant Certification, and full-time chairside dental assisting work experience.

Points Verification

The tabulation of points is completed after the January 26, 2024 deadline to submit documentation. Points verification letters will be mailed to eligible applicants by February 12, 2024. Eligible applicants will be given a specific time frame to be able to question or request a review of the calculated point total. After that time, point calculations are considered accurate and final and will not be recalculated.

Accepted Students

Up to 18 of the highest ranking applicants will be *accepted* into the Dental Hygiene Program.

- In the event that applicants have the same number of points, the HESI total score will determine ranking.
- If there is still a tie, the applicant submitting their Dental Hygiene application first will be ranked higher (date and time will be recorded on the Eligibility Application form).

Applicants will also receive an Agreement form. This form must be signed, dated, and returned by the deadline indicated in the letter and on the form. Failure to submit this form by the deadline, regardless of the date postmarked, will result in placement at the bottom of the alternate list.

Once an applicant accepts admission for any 2024 Allied Health program at Coastal Carolina Community College, all applications on file for any other 2024 Allied Health programs at Coastal will be cancelled.

An applicant who, for any reason, does not enter the 2024 Dental Hygiene Program must reapply for the 2025 program, attend a 2025 Dental Information Session, and meet all admission requirements to be considered for the 2025 Dental Hygiene Program.

Alternates

All remaining qualified applicants will be placed on the alternate list. Should a space become available prior to the start of the program, the next qualified alternate will be notified.

Notification

The following letters will be mailed to qualified applicants by March 4, 2024:

- Acceptance letter Up to 18 highest-ranking applicants
- Alternate letter next group of up to 18 highest-ranking applicants
- **Denial letter** all other qualified applicants

It is every applicant's responsibility to notify the Admissions Office as well as the Academic Advisor/Counselor designated for the Dental programs of any address and/or phone number changes.

Points are awarded for grades received in college-level courses within the Dental Hygiene Program.

Applicants are **not** required to complete these courses prior to beginning the program. However, it is helpful to the applicant's overall ranking to have completed as many of these courses as possible by the end of Fall 2023.

Applicants may be awarded points for equivalent courses completed at another accredited college with a grade of C or higher. Grade points will be valued according to Coastal Carolina Community College's grading scale and will be awarded by the letter grade on the transcript. In order for these courses to be considered for points, transcripts must be received by 5:00 p.m. on January 26, 2024.

Submission of AP or CLEP scores satisfies requirement for the course, and applicants may submit scores for points or take the course for points but may not receive points for both.

Additional Points for Point System A

Dental Hygiene applicants may earn additional points for the following:

- Completion of (or current enrollment in) an American Dental Association accredited Dental Assisting Program
- Work experience
- Current Dental Assisting National Board certification
- Completion of ACA 111 College Student Success or ACA 122 College Transfer Success

- The fall semester GPA will be used for currently enrolled Dental Assisting students in an American Dental Association (ADA) accredited program if all of the courses required in the catalog for the fall semester have been successfully completed with a grade of C of higher. All DEN courses and related courses completed by the end of the fall semester will be counted in the GPA calculation only for the Dental Assisting fall semester.
- Any points received for the fall GPA will be revoked if the applicant does not graduate from the Dental Assisting Program. Revoking these points could result in removal from the Dental Hygiene acceptance list.
- In the event an applicant has completed and graduated from an ADA accredited Dental Assisting program, equivalent to the Dental Assistant II level, and the institution awarding the diploma/certification does not indicate a final cumulative GPA or if the applicant has completed and graduated from an ADA accredited Dental Assisting program and their final cumulative GPA is below a 3.00, two points will be awarded.

ACA 111 or ACA 122

Applicants who complete ACA 111 College Student Success or ACA 122 College Transfer Success with an A in the course will earn two additional points.

High school course work may be submitted for points only if the course is worth 1 credit.

If the student will have completed all of the related courses by the end of Fall 2023, Point System A must be used for their application.

For the purposes of North Carolina Common Core Integrated Math courses, the following are equivalents under Point System B: Math I = Algebra I, Math II = Geometry, Math III = Algebra II.

Honors, AP, and IB designated courses with grades of A or B will receive one additional point in each category.

Grade points will be valued according to Coastal Carolina Community College's grading scale and will be awarded by the letter grade received on the transcript.

Point System A and Point System B **cannot** be combined. If the applicant is eligible for consideration under both point systems, the higher point total will be used for ranking.

High school equivalency scores will not be used to determine points. Only courses actually completed in high school, for which an applicant received an overall grade for performance, can be utilized to determine points.

Additional Points for Point System B

Dental Hygiene applicants may earn additional points for the following:

- High school class ranking
- Work experience
- Current Dental Assisting National Board certification
- Completion of Health Science or Biomedical Technology
- HESI scores

High School Class Ranking

Applicants are awarded points for their current or final senior year class ranking. There must be at least two students enrolled in the senior class for the year the applicant graduates.

Health Science or Biomedical Technology Courses

Only work experience as a full-time (32 or more hours per week) chairside dental assistant will be counted. All work experience will be documented through an Employment Verification Form. The applicant will send the form to the dentist(s). The form needs to be faxed or mailed back to the Academic Advisor/Counselor designated for the Dental programs and received by January 26, 2024.

Section 2: Dental Hygiene Program Information

Important Notes

Candidates accepted to the Dental Hygiene Program must attend an orientation/registration meeting.

Candidates accepted to the Dental Hygiene Program must upload the Student Medical Form, dental and eye examination forms, a copy of their American Heart Association CPR card, drug screen, background check, and all required titers and vaccination documentation to the CastleBranch program.

Dental Hygiene students must be aware of the importance of regular class attendance in order to be successful in their classes. Applicants should coordinate doctor appointments and vacations with College holidays and breaks. Also, it is vital to have child care arrangements worked out in advance in case of children's illnesses, teacher work days, etc. If excess absences are accumulated, then a Dental Hygiene student will be dropped from the program in accordance with the attendance guidelines in the *College Catalog*.

Dental Hygiene students are strongly advised to limit the number of hours they are employed in order to maximize their potential for academic success in the Dental Hygiene Program.

Course substitutions must be completed prior to the start of the program. Once a student has started in the Dental Hygiene Program, all Dental Hygiene and related courses not previously completed must be taken as listed in the student's catalog of record. Exceptions must be approved by the Dental Department Head.

Dental Hygiene Program Goals

The Dental Hygiene Program goals are detailed below.

- 1. To provide a student-centered teaching environment that engages the students as active learners.
- 2. To educate dental hygiene students in the ethical, legal, and competent practice of dental hygiene.
- 3. To comprehensively prepare students with the knowledge and skills to assess, formulate a dental hygiene diagnosis, plan, implement, and evaluate dental hygiene care for the individual and the community.
- 4. To prepare dental hygiene graduates who provide patient-centered, comprehensive, evidence-based dental hygiene care.
- 5. To develop the interpersonal and patient-centered skills to interact effectively with diverse populations.
- 6. To promote professional growth, scientific inquiry, and an appreciation for lifelong learning.
- 7. To educate students on current technologies and the skills necessary to adapt to a rapidly changing healthcare system.
- 8. To engage students in the promotion of dental health ideals through service to the community and involvement with professional organizations.

Scope of Practice for Dental Hygienists

Dental hygienists licensed in the State of North Carolina may perform all functions of a dental hygienist as described by the North Carolina Practice Act.

Dental Hygiene Employment Opportunities

There are a variety of employment opportunities for graduates of the Dental Hygiene Program. These options include, but are not limited to, the following:

- Private practice general dentistry and specialties contract services for military installations
- State institutions prison system, public health organizations, special needs organizations
- Supply companies/sales
- Consulting

Dental Hygiene Curriculum Description

The Dental Hygiene curriculum prepares individuals with the knowledge and skills to assess, plan, implement, and evaluate dental hygiene care of the individual and the community.

Students will learn to prepare the operatory, take patient histories, note abnormalities, plan care, teach oral hygiene, clean teeth, take x-rays, apply preventive agents, complete necessary chart entries, and perform other procedures related to dental hygiene care.

Graduates of this program may be eligible to take national and state/regional examinations for licensure which are required to practice dental hygiene. Employment opportunities include dental offices, clinics, schools, public health agencies, industry, and professional education.

Coastal Carolina Community College offers the Dental Hygiene program as an Associate in Applied Science degree. The appropriate course work is listed below.

Academic Regulations

Once accepted in the Dental Hygiene Program, students must meet the following academic standards:

- Maintain grades of C+ (77%) or higher on all dental (DEN prefix) courses. For science courses, students must maintain a grade of C (73%) or higher. For all other related courses, students must maintain a grade of C- (70%) or higher. Students will be disenrolled if requirements are not met.
- Students must complete all the courses no later than the semester they are scheduled in the *College Catalog*. Failure to do so will result in dismissal from the program.
- The possible transfer of Dental (DEN prefix) courses will be evaluated according to written College guidelines. General Education courses in the Dental programs are transferable according to the guidelines of the Comprehensive Articulation Agreement. The transferability of Dental (DEN prefix) courses is at the discretion of the receiving institution.

Readmission/Transfer Procedure

A student requesting consideration for readmission or transfer must have an overall GPA of at least 2.0. The full readmission policy may be found in the current *Dental Hygiene and Dental Assisting Policies and Procedures Manual*.

- Anyone interested in readmission or transfer must contact the Dental Department Head.
- The decision will be made by the Dental Programs Readmission Selection Committee and will only be considered on a space-available basis.

Costs listed above are estimates and subject to change. The In-State tuition rate is based on \$76 per credit hour plus student fees. Tuition rates are determined by the North Carolina General Assembly and are subject to change at their discretion.

- Applicants should complete FAFSA; North Carolina Student Loan Program for Health, Science, and Mathematics form; Coastal Carolina Community College Foundation scholarship form; and other scholarship forms as soon as possible.

Dental Hygiene Program-Related Requirements

Cardiopulmonary Resuscitation

All Dental Hygiene students must be certified in American Heart Association Health Care Provider Level cardiopulmonary resuscitation (CPR) at intervals not to exceed two years. A copy of such certification must be uploaded into the immunization tracker system before the first day of class. Certification must be maintained through graduation. Documentation must be on file for any student who is medically or physically unable to perform such services.

Communicable Disease Statement

Although there are no documented cases of the occupational spread of HIV to dental workers, students enrolled in the Dental Hygiene Program are at a slight risk of exposure to blood and body fluids and the potential does exist for transmission of bloodborne and other infectious diseases during patient care activities. The risk of HIV disease transmission from dental patients to members of the dental team is extremely low. Nevertheless, there is some small potential for this to occur. The Americans with Disabilities Act forbids discrimination against patients with HIV; therefore, students are required to treat all patients assigned, regardless of the disease state of the patient. Refusal to treat any patient may affect the student's academic success.

Students who enter the Dental Hygiene Program will be required to read and sign a Communicable Disease Statement and Waiver of Liability form. This form will become a part of the student's permanent record and will state that the student:

- Has been informed of their risk for exposure to blood and body fluids;
- Understands the potential for transmission of bloodborne diseases during patient care activities; and,
- Agrees to care for all patients that are assigned to them.

The student and a witness must sign the communicable disease statement. Students who are minors must have the form signed by a parent or legal guardian.

Training in Infection Control Procedures

No student will be allowed to deliver patient services in any setting until they have been instructed in infection control (as per OSHA guidelines) and have mastered material on safety and/or universal precautions with satisfactory accuracy. Following mastery of infection control skills and under faculty supervision, each student will be expected to provide services for patients with health deviations, including patients with HIV/HBV and other blood borne/infectious diseases, as part of routine clinical/lab curriculum experiences.

North Carolina State Board Examination

Dental Hygiene students should be aware that the following questions must be answered when completing the North Carolina State Board of Dental Examiners Application for Licensure to Practice Dental Hygiene. The answers to these questions may determine the applicant's eligibility to take the State Board examination. Applicants should contact the Board if they have any questions.

- "Have you ever been summoned, arrested, taken into custody, indicted, convicted or tried for, or charged with, or pleaded guilty to the violation of any law or ordinance or the commission of any felony or misdemeanor (excluding traffic violations), or have you been requested to appear before any prosecuting attorney or investigative agency in any matter? (Include all such incidents no matter how minor the infraction or whether guilty or not.) Although a conviction may have been expunged from the records by order of the court, it nevertheless must be disclosed in your answer to this question."
- "Within the last ten years, have you been addicted to or received treatment for drugs, alcoholism, or afflicted with a serious communicable disease? If yes, give full details of your treatment."
- "Have you ever been denied admission to any college or school for cause that reflects adversely on your character?"
- "Have you been dropped, suspended, expelled, or disciplined by any school or college for any cause whatsoever? If yes, please list on a separate sheet of paper the date, school and nature of cause."
