Things You Should Know Before You Apply

Upon acceptance into the Coastal Carolina Community College (Coastal) Emergency Medical Science (EMS) Program, students will be required to:

- Obtain proof of required immunizations and health screenings for clinical participation by purchasing a vaccination tracker, due by **September 3, 2024** to the Director of the EMS Program.
- Undergo random drug testing and criminal records check prior to beginning clinical rotation. These costs are at the student's own expense. The information provided in the criminal background check and drug screening is not considered in the admission decision. It is possible, however, that the results may prevent the applicant from participating in the clinical rotations and from continuing in the program.
- Obtain and maintain current certification in American Heart Association's Basic Life Support for Health Care Providers (often referred to as BLS or CPR).
- Travel at their own expense to clinical locations in order to complete clinical requirements of the program. In addition, alternative clinical assignments may need to be assigned to meet clinical case and hour requirements.
- Follow agency personnel policies regarding body piercing/gauging ornaments and tattoos.
- Have a valid United States driver's license.

Students are strongly advised to keep copies of their submitted forms.

Admissions Information

The application period for the 2024 EMS Program begins April 10, 2024, and ends August 14, 2024. Students will not be considered for admission until they have completed eligibility requirements (Level 1) and an EMS Eligibility Application (Level 2). Students are admitted on a first-come, first-served basis.

Applicants utilizing financial aid are encouraged to apply as early as possible in order to have access to their financial aid award for tuition, fees, and the purchase of books and supplies.

Anatomy and Physiology requirements, if completed prior to the program, must have been completed within five years of the entry term of the program (during or after Fall 2019).

All current or returning students must have a cumulative GPA of 2.0 or higher and have prior approval from the Academic Advisor/Counselor designated for the EMS Program and the Director of the EMS Program before being eligible to apply.

The application process begins **April 10, 2024** and ends **August 9, 2024** (or when the program is filled). All EMS Program applicants must meet placement requirements.

- 1. Complete the Residency Determination application. The application is available online at www.coastalcarolina.edu.
- 2. Complete the Coastal Admissions application. The application is available online at <u>www.coastalcarolina.edu</u>.
- 3. Submit all official transcript(s) to the Admissions Office. Official transcripts include:
 - High school (or high school equivalency)
 - All colleges or schools attended after high school
 - CLEP (College Level Examination) scores
 - AP (Advanced Placement) scores
- 4. Demonstrate college readiness in both English **and** mathematics by meeting <u>one</u>, or a combination, of the following to show required knowledge in each subject:
 - i. Graduated from any United States high school within the last 10 years with a GPA of 2.8 or higher, in accordance with Reinforced Instruction for Student Excellence (RISE) guidelines.
 - ii. Completed (with a minimum of the grade indicated) or enrolled in one of the following English courses:

- v. Completed a college-approved placement test (e.g., RISE, NC DAP, Compass, ASSET, SAT, ACT, or Accuplacer/CPT) and meet the minimum college readiness scores, as provided in Table 1. Test scores must be earned on or after August 1, 2022.

NOTE: For applicants using course completion to meet placement, both an English and mathematics option must be completed to meet the eligibility requirements, and applicants who are unsure whether or not they meet either the English or the mathematics standards should meet with an Academic Advisor/Counselor. Applicants taking a placement test at a location other than Coastal must submit official test scores prior to meeting with an Academic Advisor/Counselor to complete an Eligibility Application.

 - ENG 111 Writing and Inquiry (or an equivalent college composition course) with a grade of C or higher
 - MAT 143 Quantitative Literacy, MAT 161 College Algebra, or MAT 171 Precalculus Algebra (or an equivalent algebraic college mathematics course) with a grade of C or higher
- 6. Complete an Eligibility Application with the Academic Advisor/Counselor designated for EMS (or their designee) no later than 5:00 p.m. on August 14, 2024.
- 7. Contact the Director of the EMS Program to schedule an interview.
- 8. Ensure updated transcripts for courses completed in Spring 2024 or Summer 2024 (if applicable) are on file at Coastal no later than August 14, 2024.
 - Please be aware that if an applicant is completing the math or English course(s) required to apply for the Fall 2024 semester and the transcript is not on file at Coastal by the deadline (regardless of the date postmarked), the applicant will be considered ineligible for admission into the 2024 EMS Program.

Content

• Students will be tested in the following areas: reading comprehension, grammar, vocabulary, and mathematics.

Availability

• The HESI exam may take up to four hours. The exam is available Monday – Thursday (8:00 a.m. or 1:00 p.m.) or Fridays (8:00 a.m.) on Coastal's main campus. Available appointment times are viewable two weeks in advance. The testing schedule is subject to change.

Registration and Payment

- Applicants must register and pay online for the HESI exam ahead of time by setting up an Evolve/Elsevier account. The estimated cost of the exam is \$54, but it is subject to change. A study guide is available for purchase in the College Store.
- Payment must be completed at least 24 hours in advance of the testing appointment.
- Applicants will obtain the payment link from an Academic Advisor/Counselor after completing their Eligibility Application.

Schedule an Appointment

- Applicants should schedule an appointment with the Testing and Placement Center through the Admissions page of Coastal's website (click on the Placement Testing tile).
- If an applicant must cancel the appointment, they must notify the Testing and Placement Center at least 24 hours in advance. Failure to do so may result in an applicant being unable to make another appointment.
- Due to limited testing space, if an applicant misses or cancels two appointments, they will not be able to reschedule for two weeks after the last missed or cancelled appointment.

Scores

- Official scores will be available 48 hours after testing and may be viewed through an Evolve/Elsevier account.
- If an applicant decides to test a second time, they must pay the exam fee again (through a payment link obtained from an Academic Advisor/Counselor).
- Applicants may take the HESI twice in a cycle year (September 1, 2023 August 31, 2024) at Coastal.
- HESI scores must be completed within three years prior to entering the program to be valid for the application process (during or after August 2021).

Off-Site Testing

- It is the applicant's responsibility to locate an alternate testing site. Coastal does not have a testing ID to provide to other sites.
- If a student tests at another site, they must request an official transcript to be sent directly to Coastal (through the HESI website) for an additional fee.

Remote/Virtual Testing

• A virtual testing option is available and subject to an additional fee. Please see an Academic Advisor/Counselor for more information.

A qualified applicant is defined as an applicant who meets all Level 2 eligibility requirements and submits a complete EMS Eligibility Application during the application period (April 10, 2024 – August 14, 2024).

Students are admitted on a first-come, first-served basis after successful completion of eligibility requirements, to include meeting with the Director of the EMS Program. The **first 30** qualified applicants will be admitted to the Fall 2024 EMS Program.

All other qualified applicants who apply by the deadline will be placed on an alternate list in the order of which they applied. Should any of the originally accepted candidates be unable to enter the program, alternates will be selected to take their places in the order of which they applied.

Students not admitted to the EMS Program must reapply if they wish to be considered for a future class.

Credit for Prior Learning Approval: EMT

Students who have an active Emergency Medical Technician (EMT) credential and are not under suspension/investigation or other derogatory status may be eligible to receive credit for EMS 110 through credit for prior learning. Credit for prior learning applications must be submitted through Admissions by December 15, 2024.

Students who receive credit for EMS 110 must meet all other pre-requisites to enter the paramedic program in the spring semester.

Section 2: Emergency Medical Science Program Information

Students accepted to the EMS Program must attend an orientation session prior to the first day of the Fall semester. They will register for Fall classes at that time (students accepted into the program after this date must meet with the Director of the EMS Program prior to registering for classes).

- Two orientation sessions will be held on Thursday, July 25, 2024. One session will begin at 9:00 a.m. and the other will begin at 6:00 p.m. <u>Students only have to attend one orientation session</u>.
- Both sessions will be held on Coastal's main campus in the W.D. "Billy" Mills Math and Science Technology Building, room 120.

Students admitted to the EMS Program need to be aware of the importance of regular class attendance in order to be successful in their classes. It is vital to have childcare arrangements worked out in advance in case of children's illnesses, teacher work days, etc. If excess absences are accumulated, the student will be administratively withdrawn from the program in accordance with the attendance policy outlined within the *College Catalog*.

Students are strongly advised to limit the number of hours they are employed in order to maximize their potential for academic success in the EMS Program.

Students assigned to approved clinical practicum sites will be required to undergo drug testing and to complete a criminal background check prior to beginning clinical rotations. A positive finding on the drug screen or the results of the criminal background check may prevent the student from continuing in the program. The decision will be made by clinical agency representatives.

If you have any questions regarding the submission of the criminal background check or drug screening, or how the submission of these documents may affect your progression in the program, please contact the Director of the EMS Program.

Once enrolled in the EMS Program, students will be required to:

- Complete all required immunizations. Completion of a COVID-19 vaccination series may be required by the clinical agencies for participation.
- Purchase an immunization clinical tracker and submit to the Director of the EMS Program by September 3, 2024.
- Demonstrate physical and emotional health as evidenced by appropriate behavior as outlined in the *EMS Program Manual*.
- Purchase EMS Testing at the beginning of the first semester of the program (more information will be provided at orientation).
- Pay for liability insurance annually (will be included in fall semester tuition and fees).
- Adhere to the student guidelines specific to the EMS Program as outlined in the EMS Program Manual.
- Travel at one's own expense to complete clinical and field training.

Students enrolled in the EMS Program are at risk of exposure to blood and body fluids, and the potential does exist for transmission of bloodborne and other infectious diseases during patient care activities. The Americans with Disabilities Act forbids discrimination against patients with human immunodeficiency virus (HIV); therefore, students are required to treat all patients assigned, regardless of the disease state of the patient. Refusal to treat any patient may affect the student's academic progress.

Students who enter the EMS Program will be required to read and sign a Communicable Disease Statement and Waiver of Liability form. This form will become a part of the student's permanent record and will state that the student:

- Has been informed of their risk for exposure to blood and body fluids.
- Understands the potential for transmission of bloodborne diseases during patient care activities.
- Agrees to care for all patients assigned to them.

The student and a witness must sign the Communicable Disease Statement. Students who are minors must have the statement signed by a parent or legal guardian.

The complete Communicable Disease Statement is available in the EMS Program Manual.

The Emergency Medical Science curriculum provides individuals with the knowledge, skills and attributes to provide advanced emergency medical care as a paramedic for critical and emergent patients who access the emergency medical system and prepares graduates to enter the workforce. Students will gain complex knowledge, competency, and experience while employing evidence-based practice under medical oversight, and serve as a link from the scene into the healthcare system. Graduates of this program may be eligible to take state and/or national certification examinations. Employment opportunities include providers of emergency medical services, fire departments, rescue agencies, hospital specialty areas, industry, educational and government agencies. Coastal Carolina Community College requires that students complete all degree requirements to establish eligibility to take the paramedic certification examination.

Additional EMS Academic Regulations

• EMS Courses:

Students must complete EMS courses with a numerical grade of 77 or higher in order to progress in the EMS Program. If the student does not receive a numerical grade of 77 or higher in any EMS course, they will be required to withdraw from the program.

• Anatomy and Physiology (BIO 168 and BIO 169) Requirement:

BIO 168 and BIO 169 must be completed by the beginning of the third semester in which the student is enrolled Emergency Medical Science Program with a grade of C or higher to ensure student success. If the student does not successfully meet the requirement, they will be required to withdraw from the EMS Program.

Please Note: Anatomy and Physiology requirements, if completed prior to the program, must have been completed within five years prior to the entry term of the program (during or after Fall 2019).

• <u>All Other Non-EMS Courses</u>:

A student who withdraws or receives an F in any non-EMS (related) courses—except BIO 168 and BIO 169 may be permitted to continue, provided the student can complete the course(s) by the end of the summer session following their expected date of graduation.

Readmission

Applicants seeking readmission or transfer into the EMS Program must meet all current requirements. Readmission will be permitted contingent upon space availability, in accordance with the *EMS Program Manual*, and policies set forth by the North Carolina Office of Emergency Medical Services and the North Carolina Medical Board.
