## Things You Should Know Before You Apply

Upon acceptance into the Coastal Carolina Community College (Coastal) Emergency Medical Science (EMS) program, students will be required to:

- Adhere to all aspects of North Carolina Office of Emergency Medical Services (NC OEMS) and clinical agency minimum age requirements. Students must be at least 18 years of age prior to starting the spring semester of the first year to meet the minimum age requirement of NC OEMS and all clinical agencies.
- Obtain proof of required immunizations and health screenings for clinical participation by purchasing a vaccination tracker, due by **September 2, 2025** to the Director of Emergency Medical Science.
- Undergo random drug testing and criminal records check prior to beginning clinical rotation. These costs are at the student's own expense. The information provided in the criminal background check and drug screening is not considered in the admission decision. It is possible, however, that the results may prevent the applicant from participating in the clinical rotations and from continuing in the program.
- Obtain current certification in American Heart Association's Basic Life Support for Health Care Providers (often referred to as BLS or CPR) prior to the start of clinical rotations. This certification must be maintained through the duration of the program. Additional information will be provided during the EMS orientation.
- Travel at their own expense to clinical locations in order to complete clinical requirements of the program. In addition, alternative clinical assignments may need to be assigned to meet clinical case and hour requirements.
- Follow agency personnel policies regarding body piercing/gauging ornaments and tattoos.
- Have a valid state-issued driver's license.
- Students who face injury, illness, or other health-related matters while enrolled in the Emergency Medical Science program may be required to submit a certification of readiness to return to school from a medical professional prior to returning to the classroom or clinical environment. This certification should clearly state in writing that a medical provider has certified readiness to return to school, specifically at Coastal Carolina Community College, and that the student is able to function as an EMS provider in both pre-hospital and hospital settings.

## Admissions Information

---

The application period for the 2025 EMS program begins April 7, 2025, and ends August 14, 2025. Students will not be considered for admission until they have completed eligibility requirements (Level 1) and an EMS Eligibility Application (Level 2). Students are admitted on a first-come, first-served basis.

Applicants utilizing financial aid are encouraged to apply as early as possible in order to have access to their financial aid award for tuition, fees, and the purchase of books and supplies.

Anatomy and Physiology requirements, if completed prior to the program, must have been completed within five years of the entry term of the program (during or after Fall 2020).

All current or returning students must have a cumulative GPA of 2.0 or higher and have prior approval from the Academic Advisor/Counselor designated for the EMS program and the Director of Emergency Medical Science before being eligible to apply.

## EMS Program Requirements for Eligibility – Level 1

The application process begins **April 7, 2025**, and ends **August 14, 2025** (or when the program is filled). All EMS program applicants must meet placement requirements.

1. Complete the Residency Determination application. The application is available online at [www.coastalcarolina.edu](http://www.coastalcarolina.edu).
2. Complete the Coastal Admissions application. The application is available online at [www.coastalcarolina.edu](http://www.coastalcarolina.edu).
3. Submit all official transcript(s) to the Admissions Office. Official transcripts include:
  - High school (or high school equivalency)
  - All colleges or schools attended after high school
  - CLEP (College Level Examination) scores
  - AP (Advanced Placement) scores
4. Meet minimum college-approved placement requirements in both English **and** mathematics by meeting one, or a combination, of the following:
  - i. An associate degree or higher from an accredited institution; or
  - ii. Graduated from any United States high school within the last 10 years from the start of the program with an unweighted GPA of 2.8 or higher; or
  - iii. Completed a college-approved placement test and meet the minimum scores listed in Table 1 (Test scores must be earned on or after August 1, 2022); or

## EMS Program Requirements for Eligibility – Level 2

---

5. Demonstrate competency in reading, grammar, vocabulary, and mathematics by meeting **one** of the following to show required knowledge in each subject area:

- i. Complete the Health Education Systems Incorporated (HESI) A<sup>2</sup> exam and earn at minimum the following scores:

- ii. Completion of **both** college-level English and college-level mathematics:
- ENG 111 Writing and Inquiry (or an equivalent college composition course) with a grade of C or higher
  - MAT 143 Quantitative Literacy, MAT 161 College Algebra, or MAT 171 Precalculus Algebra (or an equivalent algebraic college mathematics course) with a grade of C or higher

6. Complete an Eligibility Application with the Academic Advisor/Counselor designated for EMS (or their designee) no later than 5:00 p.m. on the final day of the application period.

8. Ensure updated transcripts for courses completed in Spring 2025 or Summer 2025 (if applicable) are on file at Coastal no later than 5:00 p.m. on the final day of the application period.
- Please be aware that if an applicant is completing the math or English course(s) required to apply for the Fall 2025 semester and the transcript is not on file at Coastal by the deadline (regardless of the date postmarked), the applicant will be considered ineligible for admission into the 2025 EMS program.



# Health Education Systems Incorporated Exam Details

---

## Content

- Students will be tested in the following areas: reading comprehension, grammar, vocabulary, and mathematics.

## Availability

- The HESI exam may take up to four hours to complete. The exam is available Monday – Thursday (8:00 a.m. or 1:00 p.m.) or Friday (8:00 a.m.), on Coastal’s main campus. Available appointment times are viewable two weeks in advance. The testing schedule is subject to change. Please know, payment must be completed prior to scheduling the testing appointment.

## Registration and Payment

- Applicants must obtain the payment link from an Academic Advisor/Counselor.
- Applicants must register and pay online for the HESI exam ahead of time by setting up an Evolve/Elsevier account. The estimated cost of the exam is \$55 but is subject to change. A study guide is available for purchase in the College Store.
- Payment must be completed prior to scheduling the testing appointment.

## Schedule an Appointment – Seated

- Applicants must schedule an appointment with the Testing and Placement Center through the Admissions page on Coastal’s website (click on the Placement Testing tile).
- If an applicant must cancel the appointment, they must notify the Testing and Placement Center at least 24 hours in advance. Failure to do so may result in an applicant being unable to make another appointment.
- Due to limited testing space, if an applicant misses or cancels two appointments, they will not be able to reschedule for two weeks after the last missed or cancelled appointment.

## Scores

- Official scores may be viewed through the applicant’s Evolve/Elsevier account.
- If an applicant decides to test a second time, they must pay the exam fee again (through a payment link obtained from an Academic Advisor/Counselor).
- Applicants may take the HESI twice in an eligibility period (September 1 – August 31) at Coastal.
- HESI scores must be completed within three years prior to entering the program to be valid for the application process (on or after August 1, 2022).

## Off-Site Testing

- It is the applicant’s responsibility to locate an alternate testing site. Coastal does not have a testing ID to provide to other sites.
- If a student tests at another site, they must request an official transcript to be sent directly to Coastal (through the HESI website) for an additional fee.

## Remote/Virtual Testing

- Remote/virtual testing is available through ProctorU. The estimated cost of the exam is \$75 but is subject to change. Please see an Academic Advisor/Counselor for more information.

## Americans with Disabilities Act (ADA) Accommodations

- Applicants must have an approved accommodation on file with the college to receive ADA accommodations for the HESI. Prior to any implementation of accommodation services, applicants must contact the Coordinator for Disability Support Services at (910) 938-6331 or [adasupport@coastalcarolina.edu](mailto:adasupport@coastalcarolina.edu) within a reasonable timeframe to determine eligibility before purchasing the exam.

## Selection of Qualified Applicants

---

A qualified applicant is defined as an applicant who meets all Level 2 eligibility requirements and submits a complete EMS Eligibility Application during the application period (April 7, 2025 – August 14, 2025).

Students are admitted on a first-come, first-served basis after successful completion of eligibility requirements, to include meeting with the Director of Emergency Medical Science. The **first 30** qualified applicants will be admitted to the Fall 2025 EMS program.

All other qualified applicants who apply by the deadline will be placed on an alternate list in the order of which they completed an EMS Eligibility Application. Should any of the originally accepted candidates be unable to enter the program, alternates will be selected to take their places in the order of which they applied.

Students not admitted to the EMS program must reapply if they wish to be considered for a future class.

## Credit for Prior Learning Approval: EMT

---

Students who have an active, unrestricted Emergency Medical Technician (EMT) credential may be eligible to receive credit for EMS 110 through credit for prior learning. Credit for prior learning applications must be submitted through Admissions by the start of the spring semester of the first year.

Note: Students who receive credit for EMS 110 must meet all other eligibility requirements in addition to successful completion of BIO 168 Anatomy and Physiology I (with a grade of C or higher) to enter the paramedic program in the spring semester.

## Emergency Medical Science Program Information

---

Students accepted to the EMS program must attend an orientation session prior to the first day of the Fall semester. They will register for Fall classes at that time (students accepted into the program after this date must meet with the Director of Emergency Medical Science prior to registering for classes).

- Two orientation sessions will be held on Wednesday, July 23, 2025. One session will begin at 9:00 a.m. and the other will begin at 6:00 p.m. Students only have to attend one orientation session.
- Both sessions will be held on Coastal's main campus in the W.D. "Billy" Mills Math and Science Technology Building, room 120.

Students admitted to the EMS program need to be aware of the importance of regular class attendance in order to be successful in their classes. It is vital to have childcare arrangements worked out in advance in case of children's illnesses, teacher work days, etc. If excess absences are accumulated, the student will be administratively withdrawn from the program in accordance with the attendance policy outlined within the *College Catalog*.

Students are strongly advised to limit the number of hours they are employed in order to maximize their potential for academic success in the EMS program.

Students assigned to approved clinical practicum sites will be required to undergo drug testing and to complete a criminal background check prior to beginning clinical rotations. A positive finding on the drug screen or the results of the criminal background check may prevent the student from continuing in the program. The decision will be made by clinical agency representatives.

If you have any questions regarding the submission of the criminal background check or drug screening, or how the submission of these documents may affect your progression in the program, please contact the Director of Emergency Medical Science.

Once enrolled in the EMS program, students will be required to:

- Complete all required immunizations. Completion of a COVID-19 vaccination series may be required by the clinical agencies for participation.
- Purchase an immunization clinical tracker and submit to the Director of Emergency Medical Science by **September 3, 2025**.
- Purchase EMSTesting at the beginning of the first semester of the program (more information will be provided at orientation).
- Pay for liability insurance annually (will be included in fall semester tuition and fees).
- Adhere to the student guidelines specific to the EMS program as outlined in the *EMS Program Manual*.
- Travel at one's own expense to complete clinical and field training.

## Communicable Disease Statement

---

Students enrolled in Nursing and Allied Health programs are at risk of exposure to bloodborne pathogens and body fluids, and the potential exists for transmission of infectious diseases (e.g., HIV, Hepatitis, etcetera). Discrimination against patients with HIV and other infectious diseases is prohibited; therefore, students are required to treat all patients assigned. Refusal to treat any patient may affect the student's academic success.

The complete Communicable Disease Policy is available in the *College Catalog*.

Students enrolled in any Nursing and Allied Health program who test positive for HIV or Hepatitis prior to or at any point during their enrollment in the program must submit a written notification to:

Students who enter any Nursing and Allied Health program will be required to read and sign a Communicable Disease Statement acknowledgement form. This form becomes part of the student's departmental record and attests that the student:

- Has been informed of their risk of exposure to bloodborne pathogens and body fluids;
- Understands the potential for transmission of infectious diseases;
- Agrees to provide care for all patients assigned to them;
- Understands that refusal to treat any patient may affect their academic success;
- Has been informed of the complete Communicable Disease Policy; and
- Must comply with all related guidelines and procedures.

The student and a witness must sign the Communicable Disease Statement acknowledgment form.

# Emergency Medical Science Curriculum Description

---

## Associate in Applied Science A45340

The Emergency Medical Science curriculum provides individuals with the knowledge, skills and attributes to provide advanced emergency medical care as a paramedic for critical and emergent patients who access the emergency medical system and prepares graduates to enter the workforce. Students will gain complex knowledge, competency, and experience while employing evidence-based practice under medical oversight, and serve as a link from the scene into the healthcare system. Graduates of this program may be eligible to take state and/or national certification examinations. Employment opportunities include providers of emergency medical services, fire departments, rescue agencies, hospital specialty areas, industry, educational and government agencies. Coastal Carolina Community College requires that students complete all degree requirements to establish eligibility to take the paramedic certification examination.

## Academic Regulations

---

Students must maintain a minimum grade point average in accordance with the Satisfactory Academic Progress policy as described in the *College Catalog*.

### Additional EMS Academic Regulations

- EMS Courses:  
Students must complete EMS courses with a numerical grade of 77 or higher in order to progress in the EMS program. If the student does not receive a numerical grade of 77 or higher in any EMS course, they will be required to withdraw from the program.
- Anatomy and Physiology (BIO 168 and BIO 169) Requirement:  
BIO 168 Anatomy and Physiology I and BIO 169 Anatomy and Physiology II must be completed by the beginning of the third semester in which the student is enrolled in the EMS program with a grade of C or higher to ensure student success. If the student does not successfully meet this requirement, they will be required to withdraw from the EMS program.

*Please Note: Anatomy and Physiology requirements, if completed prior to the program, must have been completed within five years prior to the entry term of the program (during or after Fall 2020).*

- All Other Non-EMS Courses:  
A student who withdraws or receives an F in any non-EMS (related) courses—except for BIO 168 and BIO 169—may be permitted to continue, provided the student can complete the course(s) by the end of the summer session following their expected date of graduation.

### Readmission

Applicants seeking readmission or transfer into the EMS program must meet all current requirements. Readmission will be permitted contingent upon space availability, in accordance with the *EMS Program Manual*, and policies set forth by the North Carolina Office of Emergency Medical Services and the North Carolina Medical Board. ## Emergency Medical Science Technical Standards

**Purpose Statement:** Technical Standards are provided to students to identify a specific list of the non-academic abilities and characteristics established by a program as requirements for admission, promotion, and graduation. Section 504 of the Rehabilitation Act of 1973 defines a qualified individual as one who meets the academic and technical standards requisites for admission or participation in an education program.

All students in Emergency Medical Science are expected to meet certain essential functions/technical standards which are essential for successful completion of all phases of the program and reflect industry requirements and standards. To verify a student's ability to perform these essential functions, a student *may be required to demonstrate* the following technical standards in the table below. Meeting these standards does not guarantee employment in this field upon graduation. The ability to meet the program's technical standards also does not guarantee a student's eligibility for any certification exams or successful completion of the program.
