## INFORMATION FOR PELL STUDENTS

### DISTRIBUTION OF YOUR PELL GRANT

#### **2026 Fall - Begin Charging Books and Supplies:**

16-week/1<sup>st</sup> 8-week classes: Friday, August 7 - Tuesday, September 1, 2026

12-week classes: Monday, September 7 - Wednesday, September 30, 2026

2<sup>nd</sup> 8-week classes: Tuesday, October 6 - Friday, October 30, 2026

#### **2027 Spring - Begin Charging Books and Supplies:**

16-week/1<sup>st</sup> 8-week classes: Monday, January 4 - Thursday, January 21, 2027

12-week classes: Monday, January 25 - Friday, February 19, 2027

2<sup>nd</sup> 8-week classes: Tuesday, February 23 - Friday, March 19, 2027

#### **2027 Summer - Begin Charging Books and Supplies:**

10-week/1<sup>st</sup> 5-week classes: Monday, May 10 - Wednesday, June 2, 2027

8-week classes: Monday, May 24 - Thursday, June 17, 2027

2<sup>nd</sup> 5-week classes: Monday, June 21 - Thursday, July 15, 2027



### Cost of Living Refund

If you have a balance in your Pell Grant account after all charges have been subtracted, you'll receive a refund from Bank Mobile based on your elected refund preference. A Bank Mobile refund may take approximately 2-3 business days.

### 12-Week, 8-Week, 5-Week and 4-Week Terms

Pell will only pay for classes that you have attended and have verified attendance. 12-week, 8-week, 5-week, and 4-week terms classes that have **not** started will not be included in your eligible award hours until those terms have started and you have verified attendance for each class. Your initial Cost of Living Refund amount will be reduced and the remainder will be issued accordingly throughout the semester.

### Your Pell Grant Funds will be Adjusted if You:

- Registered for less than 12 credit hours.
- Drop/Withdraw from a course before the financial aid disbursement date or the instructor reports you as a "never attend" for the course.
- Registered for a class that is not in your program of study.
- Registered for a late start class (12-week, 10-week, 8-week, 5-week, or 4-week).
- Registered for a technical or vocational (certificate or diploma) program that requires a clock-hour conversion calculation of funds.
- Exceed the 30-credit hour limit of developmental courses.
- Registered to audit a course or for a credit by examination course.
- Close to your Lifetime Eligibility Used (LEU).

## How to Verify Class Attendance - Traditional & Online Classes

**\*\*The form can be submitted 7 days after the section census date listed on the form. Census dates may vary from class-to-class. For example, if the section census date is 09/21/2021, the form can be submitted on 09/29/2021.**

1. Access your MyCCCC portal at [www.coastalcarolina.edu](http://www.coastalcarolina.edu)
2. Click on Softdocs Etrieve
3. Click Forms
4. Click STI-Pell Grant Verification
5. Click in the Section box to select the class you are verifying attendance for
6. Select Yes or No if you are receiving the Pell Grant this semester
7. Read the consent statement, then click in the box indicating your consent
8. Click on Submit
9. The form will be transmitted electronically to the Financial Aid Office. **If you do not see the "Submit" button then, you are trying to submit it too soon.** Hard copies will not be accepted; it must be submitted electronically.
